That the Board of Commissioners approve the purchase of 38 (each) 2013 Club Car Precedent golf carts from NuView Inc. and approve the transfer of \$69,400.00 from the Fund Balance and \$18,000 from the Administrative Office Capital Equipment to cover this expenditure as recommended by Purchasing Agent Maria van Rooijen.

Scope of Work: Furnish and Deliver 38 each 2013 (Used) Club Car Precedent gas golf carts, replacements at Hudson Mills Metroparks. The purchase price also reflects trading in 38 each 2006 golf carts.

Cost per cart \$3750.00 - \$1500.00 (trade-in) = 2250.00 + 50.00 (Shipping) = \$2300.00

Background: The replacement carts are 8-years-old and represent three-fourths of the fleet. By purchasing this fleet of carts, the Metroparks are able to save approximately \$30,000 versus buying new 2015 carts. Club Car has redesigned their golf carts with a new fuel injection system and starting in 2015 the cost per cart will be approximately \$4600. Currently, all Metroparks golf carts are Club Car carts.

Action Requested: Motion to Approve

That the Board of Commissioners approve the Amendment to Agreement (dated June 17, 2013) with the Chief Pontiac Programs Committee.

Background: In August 2014, the Metroparks approved an amendment to the 10-year agreement with the Chief Pontiac Programs Committee, a Michigan non-profit corporation ("CPPC") to provide services, instruction and interpretations of historical arts which includes blacksmithing, pioneer cooking, woodcraft, fabric arts, and other historical life skills at Kensington Metropark. This amendment would have required a minimum charge of \$5.00 per participant. Following further discussions with the CPPC Board, staff recommended that the fee charged should require CPPC pay the Metroparks 10 percent of the gross revenue received from the fees charged to persons participating in CPPC programs, rather than a minimum of \$5.00 per person. The amendment to the agreement has been revised accordingly.

FIRST AMENDMENT

HCMA ("Authority") – CHIEF PONTIAC PROGRAMS COMMITTEE ("CPPC") AGREEMENT

WHEREAS, the Authority and CPPC do agree this _____ day of August, 2014 to amend the HCMA – CPPC Agreement dated June 17, 2013 to read as follows:

Page 4, Paragraph r) <u>Site Restoration.</u> Upon scheduled or early termination of the Agreement, or demand for possession of the site by the Authority due to either default or breach of this Agreement by CPPC, the CPPC shall not be required to return the site to its original condition, unless otherwise agreed upon by the parties in writing.

Page 5, Paragraph u) Operations

- i. CPPC shall not operate at KLHV any time when unsafe weather conditions exist or are imminent, as determined by KMP in its sole discretion.
- ii. KMP Park Operation staff has the discretion to limit hours of operation of CPPC at KLHV if the operation conflicts with another park event.
- iii. Fees and charges may be established by CPPC. The Authority reserves the right to approve such rates, which approval will not be unreasonably withheld. For the costs associated with KMP's operations and as part of the consideration of this Agreement, CPPC agrees to pay the Authority not less than 10 percent of the gross program revenue received from the fees or charges. Itemized reconciliation forms from these programs with number of participants and fees collected by the CPPC will be submitted to the Kensington Metropark Park Operations Department monthly. Payment for all programs will be made by October 31 of each year. Upon reasonable written request by the Authority, CPPC will allow the Authority's Controller or designee, to audit, to examine, and to make copies of or extracts from accounting records (in whatever form the records may be kept, whether written, electronic or other) relating to or pertaining to this Agreement.
- iv. Dates of operation will be established and agreed to by both Parties on an annual basis; during which the hours of operation will be 9:00 a.m. to sunset, unless otherwise agreed between the Parties. Request to operate outside the established Park Operating Hours shall be pre-approved in writing by authorized KMP staff.

Page 5, Paragraph w) Term and Termination

The term of this Agreement ("Term") shall be ten (10) years commencing on June 17, 2013 and ending June 16, 2023, unless otherwise terminated as provided in this Agreement. This Agreement may be extended only by mutual written agreement of the Parties.

This Agreement may be terminated be either Party for any reason, effective immediately upon providing written notice of termination to the other Party. CPPC shall have ninety (90) days after date of termination to remove all tangible personal property it has provided, such as bellows, anvils, tools, benches, and cooking equipment.

All other conditions of the Agreement dated June 17, 2013 between the Parties remain in full force and effect.

IN WITNESS WHEREOF, the Parties hereto agree to the foregoing amendment to the HCMA – CPPC Agreement dated June 17, 2013.

Background: In order to maintain compliance with 2014 Budget line item appropriation limits, monthly reviews have been made of Capital and Operation General Fund expenditure accounts. As a result of these reviews and subsequent review and approval by the Director, these appropriation adjustments have been recorded.

\$474,600 (23 percent) of the \$2,088,500 in General Fund appropriation adjustments made represent appropriations transferred between accounts within the same cost center.

\$1,173,100 (56 percent) of the \$2,088,500 in General Fund appropriation adjustments made represent appropriations transferred between accounts, between different cost centers.

That the Board of Commissioners approve the Landowner Agreement with the U.S. Fish and Wildlife Service for habitat restoration at Wolcott Mill Metropark and approve the proposed Memorandum of Understanding between HCMA and Macomb County Public Works in the substantial form as presented and recommended by Natural Resources and Environmental Compliance Manager Paul Muelle and staff.

Background: The Clinton River Watershed is a designated Area of Concern (AOC) under the Great Lakes Water Quality Agreement, the boundary of which includes the North Branch of the Clinton River (NBCR) which runs through Wolcott Mill Metropark. Current MDEQ guidance for developing Beneficial Use Impairment (BUI) delisting targets for the AOC includes the need to restore degraded fish and wildlife populations and loss of habitat. As much as seventy-two percent (72 percent) of the wetlands in the North Branch subwatershed have been lost according to a 2010 study by the Michigan Department of Environmental Quality (MDEQ). Additionally, more than 170 acres of potential wetland restoration areas have been identified, adjacent to approximately 11,000 linear feet of stream frontage, primarily within Wolcott Mill Metropark.

For the past two years, the Metroparks have been collaborating with Macomb County Public Works Office (MCPWO) in a floodplain/wetland restoration project at Wolcott Metropark. This project was made possible by a MDEQ 319 Grant awarded to MCPWO in the amount \$274,198. The project will restore historic hydrologic conditions to approximately 64 acres of floodplain wetland that were previously in agricultural use. The restoration of wetlands will help to reducing the flashiness, peak flow and the overall volume of water discharged to the NBCR and decrease the nutrient and sediment load to the river. An additional 53 acres of upland adjacent to the wetland sites have also been identified for priority restoration.

Among the partner agencies the MCPWO engaged for the project are the MDEQ and U.S. Fish and Wildlife Service (FWS) for their expertise in these types of restoration projects. In your package is a draft Landowner Agreement with the FWS for their involvement with the project. The work in the Agreement is twofold. First, to assist MCPWO with the design and construction of the wetland portion of the 319 Grant. This would be done at no expense to HCMA. The second portion of the Agreement, outlines FWS assistance to HCMA for the restoration of 53 acres of adjacent upland (which is not included in the 319 Grant) at a value of \$15,210; \$7,810 for HCMA reimbursable project costs, and \$7,400 in materials purchased by FWS. These expenditures would be covered by the FWS under separate GLRI funding. Additional HCMA expenses for the project are estimated to be approximate \$8,820. HCMA currently has \$30,000 appropriated for farmland restoration work at Wolcott Mill in the 2014 budget.

A stipulation of the Agreement is that HCMA agrees to not change land use of the restored areas for a period of 10 years. It does not restrict the recreational use of the property or prevent improvements like hiking or horse trails. If during the 10-year period, if a portion of the restored land changes use, then the HCMA agrees to reimburse the FWS the prorated cost of the habitat improvements.

In addition, attached is a proposed memorandum of understanding between HCMA and the Macomb County Public Works office (MCPW). MCPW will be undertaking the Project on HCMA property. This agreement authorizes the MCPW undertake the work, ensures compliance with grant requirements and addresses liability during Project construction.

PARTNERS FOR FISH AND WILDLIFE PROGRAM LANDOWNER AGREEMENT

This Landowner Agreement (Agreement), dated <u>September 8, 2014</u>, between <u>Huron-Clinton Metropolitan Authority (HCMA)</u> (Landowner), and the U.S. Fish and Wildlife Service (USFWS) is entered into pursuant to authority contained in the Partners for Fish and Wildlife Act (P.L. 109-294), the Fish and Wildlife Coordination Act (16 U.S.C. 661 et seq.) and the Fish and Wildlife Act of 1956 (16 U.S.C. 742a-j), as amended. This project was selected for funding because the Landowner(s) share(s) a common objective with the USFWS to restore habitat for the benefit of Federal trust species on private lands, and the project supports priority actions identified in the Regional Partners for Fish and Wildlife (Partners) Program Strategic Plan.

The <u>Huron-Clinton Metropolitan Authority</u>, 13000 High Ridge Drive, Brighton, Michigan 48114, hereby agrees to participate with the USFWS in conducting certain wildlife management practices on lands owned or managed in <u>Ray Township</u>, Macomb County, in the state of <u>Michigan</u>, described as follows: all of, or within, <u>Township 4 North</u>, Range 13 East, and Section 22 & 27.

In signing this Agreement and receiving the Notice of Award Letter, the Landowner(s) join(s) as a participant in a wildlife habitat improvement program and grants to the USFWS authority to complete the habitat improvement project or to personally carry out management activities with financial or material support as described in attached Exhibit A. Any donation of supplies, equipment, or direct payment from the USFWS to the Landowner for carrying out the habitat improvements is included in Exhibit A. The activities conducted pursuant to this agreement are not to replace, supplement or otherwise contribute to any mitigation or compensation that may be required of the Landowner, or other parties, as a result of any mandated requirements.

The term of this Agreement (also referred to as the habitat retention period) will be completed on 09/08/2024. This Agreement may be modified at any time by mutual written consent of the parties. It may be terminated by either party upon 30 days advance written notice to the other party(ies). However, if the Landowner(s) terminate(s) the Agreement before its expiration, or if the Landowner(s) should materially default on these commitments, then the Landowner(s) agree(s) to reimburse the USFWS prior to final termination for the prorated costs of all habitat improvements placed on the land through this Agreement. For these purposes, the total cost of the habitat improvements to the United States is agreed to be \$15,210.00.

Landowner:

The Landowner(s) or his/her land manager, with legal authority over land management decisions, guarantee(s) ownership of the above-described land and warrants that there are no outstanding rights that interfere with this Landowner Agreement.

The Landowner(s) will notify the USFWS of planned or pending changes in ownership. A change of ownership shall not change the terms of this Agreement. The Agreement and terms shall be in effect on the described land for the term of the Agreement.

The Landowner(s) agree(s) to allow access (with advance notice) to the USFWS and the other cooperating partners to implement the project described in the work plan, and to monitor project

success.

The Landowner(s) retain(s) all rights to control trespass and retains all responsibility for taxes, assessments, and damage claims.

During the habitat retention period, the landowner must maintain the habitat restored under this award.

At the end of the habitat retention period, the habitat improvement project will become the sole property and complete responsibility of the Landowner(s). There shall be no obligation to the USFWS after the term of the Agreement has expired.

The Landowner(s) will be responsible for securing any necessary permits. Technical advice and support will be provided by participating agencies in the application for the permit(s). The Landowner(s) agree(s) to identify USFWS' contribution to the project during public presentations, reports, or other information published about the project, as appropriate.

The Landowner(s) will not be responsible for replacing wildlife habitat improvements that are damaged or destroyed by severe acts of nature.

USFWS:

The USFWS will work with the Landowner(s) and any other cooperators signing this Agreement, throughout the entire Agreement term to support actions needed to ensure that the project is designed and constructed per the Agreement and functions as intended.

The USFWS, its agents, or assignees will provide advanced notice prior to accessing the Landowner(s) property to implement the project described in the work plan, and to monitor project success.

The USFWS assumes no liability for damage or injury other than that caused by its own negligence, on the above acreage. The USFWS does not assume jurisdiction over the premises by this Agreement.

Spatial Information Sharing: In accordance with the Privacy Act of 1974, permission must be obtained from the Landowner before any personal information can be released. The only information that can be shared is payment information that is authorized by law. Therefore, Landowner consent is requested to allow for sharing of spatial information about this project solely with conservation cooperators providing technical or financial assistance with the restoration, enhancement or management of fish and wildlife habitat.

Description of Habitat Improvement Project and Objectives (see attached maps and drawings):

This Great Lakes Restoration Initiative project is a cooperative effort involving the private landowner; Huron-Clinton Metropolitan Authority (HCMA), the Macomb Coutny Drain Comission, Michigan Department of Environmental Quality, Tetra Tech, and the U.S. Fish and Wildlife Service (USFWS) to restore 64.0 acres of wetland, 41.0 acres of native prairie and 13.5 acres of forested floodplain, through the Partners for Fish and Wildlife Program (PFW). The wetland restoration sites vary from floodplain forest to emergent wetlands. PFW will provide the landowner and the involved partners with technical assistance to re-establish the wetland and upland habitats.

The Macomb County Drain Commission is the grantee of a 319 MDEQ grant, they have selected HCMA to utilize the funds from the grant to restore wetlands in the Clinton River Watershed (a GLRI area of concern). HCMA has selected the engineering firm Tetra Tech, to draw up the design plans and submit the MDEQ permit for the wetland restoration project.

USFWS Biologists are providing technical assistance to Tetra Tech and HCMA and will be overseeing the survey, design, construction and restoration of the wetlands and adjacent uplands. USFWS Biologist will have input into wetland design, selection of a qualified contractor, construction and completion of the project.

USFWS will provide native grass and wildflower seed for 37.0 acres surrounding the restored wetland areas and funds to plant the seed and trees, purchased by HCMA, on 6.0 acres of floodplain.

The purpose of this project is to provide optimal nesting habitat for migratory birds and improve habitat for non-federal trust resources and local wildlife for the continuing benefit of the American people. Specifically, the PFW Biologist will provide technical assistance and oversight for the following:

Wetland Restoration (64.0 acres):

USFWS will provide technical assistance in the planning, design, construction and completion of the following wetland habitats.

Wetland Area A (9.0 acres):

Wetland Area A will be restored by building a low-level berm and excavating four shallow water areas for wildlife, to enhance water depths within the restored wetland, promote better water quality and enhance wildlife habitat. A wet meadow seed mix will be used to plant 2.0 acres of the saturated soil zone of the wetland. Please see Tetra Tech plans for design specifications.

Wetland Area B (28.5 acres):

Wetland Area B will be restored by constructing three low-level berms and excavating seven shallow water areas for wildlife, to enhance water depths within the restored wetlands, promote better water quality and enhance wildlife habitat. A wet meadow seed mix will be used to plant 4.5 acres of the saturated soil zone of the wetland. Please see Tetra Tech plans for design specifications.

Wetland Area C (11.1 acres):

Wetland Area C will be restored by building a low-level berm and excavating two shallow water areas for wildlife, to enhance water depths within the restored wetland, promote better water quality and enhance wildlife habitat. An existing area of non-native phragmites reed grass will be excavated and the material will be moved to a location off the wetland site (upland farm field), and treated with herbicide. The area will require continued spot spraying of herbicide by the landowner. A wet meadow seed mix will be used to plant 4.5 acres of the saturated soil zone of the wetland. Please see Tetra Tech plans for design specifications.

Wetland Area D (15.4 acres):

Wetland Area D will be restored by building a low-level ditch-plug/berm and excavating five shallow water areas for wildlife, to enhance water depths within the restored wetland, promote better water quality and enhance wildlife habitat. A wet meadow seed mix will be used to plant 3.5 acres of the saturated soil zone of the wetland. Please see Tetra Tech plans for design specifications.

Upland Restorations:

Native Warm Season Grassland (NWSG) Restoration/Establishment (41.0 acres)/ Cool Season Grassland (CSG) Establishment (12.0 acres):

USFWS will provide technical assistance in the planning, design, site preparation, planting and completion of the following NWSG areas.

As part of the 319 grant, and included in Tetra Tech's plans is: 10.0 acres of NWSG/forb plantings adjacent to Wetland Area A, B & D 7.5 acres of Cool Season Grass/forbs adjacent to Wetland Area B & D in the floodplain. Please see Tetra Tech plans for design specifications on planting areas.

All areas planted to CSG will be planted to trees consistent with floodplain forest by the landowner.

USFWS will design and provide NWSG & forb seed, and planting cost for 31.0 acres of NWSG and 6.0 acres of CSG & forbs. USFWS will also provide planting cost for 6.0 acres of trees.

NWSG Area A (16.0 acres):

Restoring one fallow field, totaling 16.0 acres, to native warm season grass and wildflowers (NWSG) to increase the habitat value of the property and provide nesting habitat for waterfowl and grassland dependent song birds.

The field will be planted, in Spring 2015, to Big Bluestem, Indian grass, Little blue stem at 4.0 lbs. (PLS) per acre and native wildflowers at 3.0 lbs. /acre. The USFWS will provide the landowner native grass and wildflower seed and funds to contract the planting of the seed. The Landowner will complete, or hire a contractor to complete site preparations on the field. Site preparation includes the removal of invasive and unwanted trees and shrubs from the field, mowing and applying herbicide (glyphosate @ 2qts/ac.) in 2014

NWSG Area B (2.0 acres):

Restoring one fallow field, under power lines, totaling 2.0 acres, to native warm season grass and wildflowers (NWSG) to increase the habitat value of the property and provide nesting habitat for waterfowl and grassland dependent song birds.

The field will be planted, in Spring 2015, to Big Bluestem, Indian grass, Little blue stem at 4.0 lbs. (PLS) per acre and native wildflowers at 3.0 lbs. /acre. The USFWS will provide the landowner native grass and wildflower seed and funds to contract the planting of the seed. The Landowner will complete, or hire a contractor to complete site preparations on the field. Site preparation includes the removal of invasive and unwanted trees and shrubs from the field, mowing and applying herbicide (glyphosate @ 2qts/ac.) in 2014.

NWSG Area D (13.0 acres):

Restoring one fallow field, totaling 13.0 acres, to native warm season grass and wildflowers (NWSG) to increase the habitat value of the property and provide nesting habitat for waterfowl and grassland dependent song birds.

The field will be planted, in Spring 2015, to Big Bluestem, Indian grass, Little blue stem at 4.0 lbs. (PLS) per acre and native wildflowers at 3.0 lbs. /acre. The USFWS will provide the landowner native grass and wildflower seed and funds to contract the planting of the seed. The Landowner will complete, or hire a contractor to complete site preparations on the field. Site preparation includes the removal of invasive and unwanted trees and shrubs from the field, mowing and applying herbicide (glyphosate @ 2qts/ac.) in 2014.

CSG/Floodplain re-forestation Area C (6.0 acres):

Restoring one fallow field, totaling 6.0 acres, to cool season grass (CSG) and wildflowers to increase the habitat value of the property and provide nesting habitat for waterfowl and grassland dependent song birds. This 6.0 acre grassland field will be restored to floodplain forest. The landowner will purchase trees, to be planted in 2015. USFWS will provide recommendations on tree species and provide funds for the tree planting. The landowner will purchase the trees.

The field will be planted, in Fall 2014 or Spring 2015, to Canada Wild Rye, Red Top and June Grass at 3.0 lbs. (PLS) per acre and native wildflowers at 3.0 lbs. /acre. The USFWS will provide the landowner

native grass and wildflower seed and funds to contract the planting of the seed. The Landowner will complete, or hire a contractor to complete site preparations on the field. Site preparation includes the removal of invasive and unwanted trees and shrubs from the field, mowing and applying herbicide (glyphosate @ 2qts/ac.) in 2014.

The landowner will be responsible for hiring a contractor to spray Field AREAS A, B, D and Forest Area C in Spring 2015 as needed. USFWS will reimburse HCMA for costs, not to exceed \$1,850.00. Any excess cost will be HCMA's.

Floodplain Forest re-establishment:

Native deciduous trees and shrubs species will be planted at a spacing of 8'x 8' (approximately 576 trees per acre) in Forest Area C. The planting contractor will apply herbicide in strips or bands in accordance with label directions at the time of planting and will spray the seedlings again in the spring of 2015 and 2016. Follow-up sprayings are done at the landowners cost.

Recommended Trees & Shrubs:

<u>Trees:</u> Silver Maple, Green Ash, Tulip Tree, Swamp White Oak, Northern Red Oak, Eastern Black Walnut, American Sycamore, Bur Oak, American Basswood, American Beech, Red Maple, Hickory, American Basswood, Pin Oak, Common Hackberry, Sugar Maple, White Oak. <u>Shrubs:</u> Dogwood, Hackberry, Nannyberry, American Cranberry, Spicebush, Redbud, Choke Cherry, Sand Cherry.

The USFWS will provide management advice to the Landowner during the life of the contract. Contact USFWS representative listed on the Landowner Agreement if you have any questions on the wetland restoration.

USFWS will:

- 1. Work in partnership with MDEQ, HCMA, and Tetra Tech to plan, design and complete the 64.0 acre wetland restoration project.
- 2. Review, design and oversee completion of the project as described above and in attached documents.
- 3. Reimburse the landowner for itemized project costs not to exceed \$7810.00 for Spring 2015 herbicide application on 37.0 acres, NWSG, CSG & forb planting costs for 37.0 acres, and tree planting and band spraying herbicide cost for 6.0 acres. Any excess cost will be the responsibility of the Cooperator.
- 4. Provide NWSG, CSG and forb seed for 37.0 acres. Estimated Cost: \$7,400.00.
- 5. Upon completion of each portion of the project, conduct a final inspection with the Landowner and contractors. Review maintenance and management requirements with the Landowner.
- 6. The USFWS can provide management advice to the Landowner(s) during the life of the contract. Contact the Service representative listed on the Habitat Development Agreement if you have any questions regarding native grass management.

The Landowner will:

- 1. Work with USFWS, MDEQ and Tetra Tech to complete the 64.0 acre wetland restoration 41.0 acre NWSG and 13.5 acre tree planting project.
- 2. Work with the USFWS Representative to obtain a contractor to complete the native grass planting project.
- 3. Purchase native recommended trees (18-24" whips) for planting in 6.0 acre CSG area. Trees can be hand planted by volunteers in other targeted areas of the park, and areas planted to CSG according to the Tetra Tech plans. Estimated cost of trees for 6.0 acres is: \$3500.00.

- 4. Be responsible for pre-planting herbicide treatments and site preparation of the 37.0 acres in 2014 and 2015 (as needed). Estimated value of site preparation activities is \$2,220.00.
- 5. Mow the 31.0 acres of NWSG once by July 15 of 2015 and 2016 to control unwanted grasses and weeds during the first two years of development. Estimated value of mowing is \$3,100.00.
- 6. Use prescribed burning as a tool to maintain and enhance the native grassland habitat, after establishment, every 3-5 years when possible.
- 7. Additional mowing, and strip mowing around the newly planted trees in the CSG planting, may be necessary during the first and second growing season to control unwanted weeds. Contact the PFW Biologist prior to additional mowing.
- 8. All wetland berms, spoils and disturbed areas will be final graded and seeded, by the contractor selected by the landowner, with grass.
- 9. Keep all vehicles off of the wetland berm areas for approximately 1 year after construction is finished and the area is fully vegetated and/or stabilized. Vehicles must also be restricted during times when the berm may be saturated. Any damage caused by vehicle ruts will be the landowner's responsibility to fix.
- 10. Annually inspect wetland berm for damage and woody vegetation encroachment. Take corrective action to repair problem areas.
- 11. Assume all responsibility for all maintenance activities (mowing, brush control, exotic/invasive species control, and muskrat control) associated with the project.
- 12. Maintain the project at the agreed upon water levels unless manipulation is agreed upon by the USFWS.
- 13. Maintain native grassland and wetland habitats for the length of the contract (10 years). Mowing, prescribed fire and herbicide applications may be necessary to establish and maintain the grassland.
- 14. Maintain a vegetative buffer at least equal to the wetland size around each basin, approximately 64.0 acres total. Upland buffer up to four times the wetland size is recommended to increase bird nesting opportunities and overall use by wildlife.
- 15. Attached for your use are general guidelines for the maintenance of native grasslands titled MAINTENANCE AND EVALUATION OF NATIVE WARM SEASON GRASS PLANTINGS.
- 16. Contact the Service Representative listed on the Habitat Development Agreement if you have any questions. The USFWS can provide management advice to the landowner during the life of the contract.







Memorandum of Understanding

North Branch Clinton River Wetland Restoration Project – Wolcott Mill Metropark

This Memorandum of Understanding ("Agreement"), made this day of
, 2014, by and between the Huron-Clinton Metropolitan Authority, a public body
corporate organized and operating under the provisions of Act 147, Public Acts of Michigan,
1939, whose principal offices are located at 13000 High Ridge Drive, Brighton, MI 48114
("HCMA") and Macomb County Public Works Office, and agency of the County of Macomb, by
and through its Public Works Commissioner, whose address 21777 Dunham Road, Clinton
Township, MI 48036 (hereinafter, "MCPW"). In this Agreement, either the Metroparks or
MCPW may be referred individually as Party or collectively as Parties.

Recitals:

- A. MCPW has been awarded a grant (Grant No.2012-008) from the Michigan Department of Environmental Quality ("MDEQ") for a wetland restoration project ("Project") at Wolcott Mill Metropark, Ray Township, and Michigan. The Project will implement a wetland restoration program that has been cited in numerous scientific studies as a top priority initiative for the health of the Clinton River Watershed ecology.
- B. MCPW intends to cooperate with other partners on the project including the HCMA, MDEQ and US Fish and Wildlife Service.
- C. The Project will include actions to restore hydrological processes, eradicate invasive plant species and restore native plant communities.
- D. MCPW has selected a contractor to design and manage the Project, prepare construction documents and construct the Project, which may encompass up to 100 acres of wetlands at Wolcott Mill Metropark. The Project will include wetland restoration and hydrologic improvements, all on HCMA land at no cost to HCMA.
- E. HCMA is willing to permit the construction of the Project on property owned by the HCMA, and HCMA is willing to own and maintain the Project after its completion.
- F. The Parties are willing to cooperate in the development and installation of the Project in order to fulfill the requirements of the MDEQ grant.

Now therefore, in consideration of the mutual promises contained herein, HCMA and MCPW hereto agree as follows:

1. <u>Project Design, Construction and Funding.</u> MCPW agrees to provide the design and construction of the Project in accordance with the Project documents as approved by MCPW and HCMA, and MCPW agrees to provide all necessary funding of the Project as outlined in the grant from the MDEQ.

- 2. <u>Project Plan Approval.</u> MCPW agrees that any and all proposals, project designs, and final plans and specifications shall be approved by the HCMA prior to commencement of work on HCMA property. The HCMA reserves the right to accept or reject designs or plans in whole or in part as it may deem in the best interest of HCMA. HCMA agrees to authorize MCPW, its employees, agents, contractors and Project partners to enter upon HCMA land to inspect, construct and perform needed monitoring and other tasks as required.
- 3. <u>Temporary Construction Permit.</u> HCMA agrees to authorize the construction of the Project on HCMA land in accordance with the terms and conditions of a temporary construction permit, which shall be authorized contemporaneously with this Agreement. This Agreement will not take effect unless 1) the temporary construction permit is authorized and 2) the construction of the Project is commenced within two years of the date of this Agreement, otherwise the Agreement will be null and void.
- 4. <u>Indemnification.</u> To the extent permitted by law, MCPW agrees to protect, defend, indemnify and hold the HCMA and its commissioners, officers, employees and agents free and harmless from and against any and all losses, penalties, damages, settlements, costs, charges, professional fees, or other expenses or liabilities of every kind and character arising out of or relating to, any and all claims, legal fees, liens, demands, court costs, obligations, actions, proceedings or causes of action of every kind and character in connection with or arising directly or indirectly out of this agreement and/or in the performance hereof; and furthermore, MCPW shall require its Project contractor(s) to defend, indemnify and hold harmless the HCMA and it commissioners, officers, employees and agents free and harmless there from, and shall require said contractor(s) to submit insurance of coverages and limits acceptable to HCMA, prior to commencement of the Project. Notwithstanding the foregoing, nothing in this Agreement shall constitute a waiver of any defenses, immunities and/or privileges as provided by law; all such defenses, immunities and privileges afforded to the Parties are expressly reserved.
- 5. Ownership of Project After Completion. Upon completion of the Project, ownership of the Project shall remain with HCMA. HCMA agrees to refrain from significantly altering the Project in any way that may prevent it from performing its intended purpose.
- 6. <u>Maintenance of Project by HCMA</u>. HCMA agrees to have primary responsibility for the maintenance of the Project after its completion. The HCMA reserves the right to manage and maintain the Project in the best interest of the HCMA.
- 7. <u>Termination and Modification</u>. This Agreement shall commence on the date hereto and terminate as stipulated in the MDEQ grant agreement. This Agreement shall only be modified by mutual written agreement by HCMA and MCPW.
- 8. <u>Successors and Assigns.</u> This Agreement shall be binding upon the successors and assigns of the parties
- 9. <u>No Third Party Beneficiaries</u>. This Agreement is intended solely for the benefit of the parties hereto and there are no intended third party beneficiaries of this Agreement.

- 10. <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which shall he deemed an original and all of which taken together shall constitute one and the same instrument.
- 11. <u>Severability</u>. If any provision of this Agreement or its application to any person or circumstance shall to any extent be invalid or unenforceable, the remainder of this Agreement shall not be affected and shall remain valid and enforceable to the fullest extent permitted by law. In other words, in the event that a court of competent jurisdiction determines that any material provision contained in this Agreement is invalid or unenforceable, then such determination does not render the remainder of the terms of this agreement invalid, unenforceable or void.
- 12. <u>Governing Law & Jurisdiction</u>. This Agreement shall be governed by laws of the state of Michigan.

Action Requested: Motion to Receive and File

That the Board of Commissioners give staff direction on these figures, and receive and file the Preliminary 2015 Budget estimates as recommended by Controller Franchock and staff.

Background: I am presenting information on the preliminary 2015 annual budget for review. These numbers represent the 2015 budget requests as submitted by District and Administrative staff.

During October, a committee consisting of the Director, Deputy Director, Controller, Human Resources and Chief Accountant will hold hearings with each District and the Administrative Office. Based on input from the Board and these hearings a Recommended Budget will be developed and brought back to the Board at the November Board of Commissioners meeting.

Preliminary Total Expenditures – \$53 Million

The 2015 Preliminary Budget Expenditures are up quite significantly from the 2014 initial Budget. Overall, there is an anticipated net increase of more than \$4 million. This is being driven primarily by a \$2.8 million increase in Major Maintenance Projects as the parks work to address deferred maintenance and aging facilities.

Capital Equipment requests are flat as the Metroparks continue to aggressively delay when equipment must be replaced. The 2015 request does include \$160,000 for computer equipment; \$290,000 for a site prep tractor; \$184,000 for replacement golf carts and three electronic signs to promote district events at a cost of \$36,000.

Capital Improvement Projects are budgeted at nearly the same level as 2014. This is an ambitious level that includes \$3.4 million for 16 projects that were originally planned for 2014, but were not yet started, as well as an additional \$0.6 million to complete projects begun in 2014. New projects are split between projects planned for in the recently revised Five-Year Plan (\$1.7 million) and new projects that were not anticipated during the Five-Year Plan process (\$1.9 million). New projects include a grant-funded project for phase two of the Marsh Restoration at Lake St. Clair for \$678,000.

2015 Park Operations expenditure requests (see **Schedule 6**) reflect a 3.8 percent increase from the initial 2014 budget, and a 2.2 percent increase when compared to the actual Projected 2014 expenditures. The increase in 2014 expenditures from the original plan primarily reflect the results of the change to self operation for food service (\$370,000) and the addition of an unplanned full-time position at Wolcott Mill (\$93,000). The snow and cold of last winter also increased costs in utilities, road maintenance and cross country skiing for a total of \$120,000.

The Administrative Office 2015 expenditure (see **Schedule 5**) requests are relatively flat compared to the 2014 budget. This is reflective of several significant fluctuations offsetting each other. A negotiated wage increase and increase in the use of part-time staff are offset by anticipated reductions to the current cost of retiree benefits. Reductions to minor equipment (\$90,000) partially offset requested increases to training/transportation (\$90,000), printing (\$90,000) and operating supplies (\$48,000).

Preliminary Total Revenue - \$46 Million

Property Tax Revenue is expected to increase modestly as taxable property values in four of the five counties have begun to recover. Please see **Schedule 1** for more detail on the estimation of \$28.1 million in tax revenue.

Operational Park Revenue is detailed on **Schedule 2** at \$16.6 million. The Districts have projected most revenue sources very near the 2014 budget level.

Grant revenue is targeted to remain steady at \$648,000 related to the Marsh Restoration Phase II grant from the National Oceanic and Atmospheric Administration (NOAA).

- In 2014 the rate was virtually flat, the 2013 decline was (4.13 percent), 2012 the decline was (7.2 percent) and in 2011 it was (9.4 percent).

Park Operating Revenues – \$16,570,300

2015 estimated Park Operating revenues are projected at \$16,570,300 – \$0.4 million increase over 2014 Revenue Projections (See Schedule 2). There are no significant changes anticipated in park revenue operating methodology for 2015. It is hoped that a more normal weather pattern, increased effectiveness of marketing and some fine tuning of changes implemented in 2015 will result in reaching the 2014 budgeted revenue target levels in 2015.

Interest Income - \$100,000

- Interest rates continue to remain low.
- Investable balances will continue to decrease due to cumulative impact of tax revenue declines and increased expenditures addressing deferred major maintenance and capital improvement work.

Sale of Capital Assets – \$100,000

- Due to retaining equipment longer, there was no auction of surplus equipment in 2014. It is anticipated that there will be sufficient items accumulated to hold an auction in 2015.
- This amount includes an estimate of \$60,000 relating to the sale of one fleet of golf carts.

<u>Grants - \$648,000</u>

• \$648,000 has been included for a Federal NOAA Grant Phase II Marsh Restoration at Lake St. Clair Metropark.

Donations - \$330,000

• It is anticipated that the fund development program initiated in 2014 will begin to produce increased donations above the average of \$110,000 that has historically been received.

<u>Special/Miscellaneous – \$145,000</u>

 The Metroparks will be jointly hosting the 2015 Special Parks District Forum in June with Oakland County and the State Department of Natural Resources. Revenue and expenditure for this event are included in the 2015 budget. Revenue generated from vendors and participant registration fees are expected to cover the costs associated with the event.

EXPENDITURES-\$53.2 Million

Engineering/General Planning – \$2,343,400

- Includes full time employees in Engineering Department, including field engineers, full time Planning/Natural Resource Department, part time employees; wages and fringe benefits.
- Approximately \$516,000 for outside consultant/engineering and design work is included in this number.

Capital Improvements – \$7,555,000

- See Schedule 3 and attached Schedules A, B, C and D for detail of the 54 capital improvement projects listed for 2015.
- Sixteen (16) projects are being re-budgeted from 2014 at a cost of \$3,377,000; these projects are detailed on **Schedule A**.
- Sixteen (16) Five-Year Plan 2015 projects are being requested for funding at \$1,729,000; these projects are detailed on **Schedule B**.
- Ten (10) new projects are requested for funding at \$1,851,000; these projects are detailed on Schedule C.
- Twelve (12) projects that began in 2014 are anticipated to have additional work needed in 2015 for completion at a cost of \$598,000; these projects are detailed on **Schedule D**.

Equipment – \$1,380,100

- Major equipment purchases are anticipated to continue at the level from 2014 (Projected) of \$1,317,500.
- \$160,000 is included to fund purchases associated with information technology.
- \$290,000 is planned for a site prep tractor to allow the NRC and district maintenance staffs to more efficiently deal with invasive species and other work of this nature.
- Forty (40) golf carts are planned for replacement at a cost of \$184,000.
- New for 2014 is the planned addition of three movable electronic signs at a total cost of \$36,000.

Land Acquisition – \$243,600

• Provides funding primarily for potential land acquisition. These funds represent the anticipated unspent balance from the 2014 budget. No additional funds have been taken from the Fund Balance for Land Acquisition for budget year 2015.

Major Maintenance - \$5,071,000

• In a significant initiative to address deferred maintenance and deteriorating facilities, funding for major maintenance has more than doubled from the 2014 budget amount. A record 142 projects have been funded and will be a challenge for the departments of Engineering and Planning to complete. Projects are detailed on **Schedule 4**.

<u>Administrative Office – \$6,335,300</u>

- Total 2015 requested Administrative Office expenditure budget represents a \$220,000 increase from 2014 projected expenditures of \$6,115,300; please see Schedule 5 for detail.
- Increases due to several new positions from 2014 being filled for a full year in 2015 as well as increased part time staffing as well as projected increases in employee group insurance are more than offset by expected decreases in the cost of current retirees.
- Transportation and Training costs are projected to increase by more than \$90,000.
- Printing is anticipated to increase by nearly \$90,000.
- An increase is also being requested in operating supplies in excess of \$48,000.
- Offsetting these increases is a reduction in minor equipment of more than \$90,000.

Park Operations – \$30,285,500

- Total 2015 budgeted Park Operations is up slightly more than 2 percent from 2014 projected expenditures of \$29,641,100; please see **Schedule 6** for detail.
- Full-time wages are requested to increase by 1 percent reflecting the negotiated wage increase agreed to in the employee bargaining agreements.
- Part-time wages are projected to increase more than \$640,000 (11 percent). This is by far the largest increase of any category.
- Offsetting these increases are decreases in fringe benefits (\$205,000), overtime (\$64,000), repair/maintenance of facilities (\$159,000) and outsourced equipment repairs (\$43,000).
- For 2015, park staff has been challenged to reduce operating expenditures from the July budget level by 1 percent. This amount has been budgeted in the administrative miscellaneous account for each park. These funds are potentially available for specific projects should the park be able to reach and maintain the cost reductions.

That the Board of Commissioners approve the firm of Abraham and Gaffney, P.C. to conduct the Metroparks financial statement audit for the years 2014 to 2016.

Summary: A Request for Proposal (RFP) was prepared in August for audit services; responses were received from five firms. Fees for the three-year term of the contract are indicated below.

Abraham and Gaffney, Plante Moran, and Rehmann were selected as preferred finalists based on a review of the proposals for technical qualifications, staff qualifications and cost. References were then contacted for these three firms and interviews were scheduled with a committee consisting of HCMA staff, James VanLeuven, consultant and Commissioner McCarthy, Treasurer. As a result of the interviews, the committee felt Plante Moran made the strongest presentation, however concern was expressed regarding the significant price difference. For this reason, staff supports Commissioner McCarthy's recommendation that we award the contract for audit services to Abraham and Gaffney, P.C.

Background: The Metroparks had last conducted a formal request for proposal for audit services in 1998 and selected Rehmann Robson. The Board of Commissioners has extended the contract with cost increases in 2002, 2006 and 2010. Although the Board had not expressed concerns with the services provided, it seemed practical to survey the marketplace at this time.

Abraham and Gaffney, P.C. was founded in 1991, when the firm of Dale J. Abraham, P.C. added Michael T. Gaffney, CPA, as principal responsible for governmental and nonprofit accounting and auditing services. The firm is organized as a professional corporation and is classified as a local firm. Since 1991, the firm has grown to three offices and currently employs approximately 40 team members and approximately 25 are members of the governmental and nonprofit audit team.

Present and past clients for Abraham and Gaffney include Traverse City and Garfield Township Recreation Authorities, DeWitt Area Recreation Authority and the cities of Ann Arbor, Ferndale, Pleasant Ridge and Utica.

Subject: Update – MDNR Trust Fund Grant and the Washtenaw County

Border-to-Border Trail

Location: Hudson Mills Metropark, Washtenaw County

Date: October 2, 2014

Action Requested: Motion to Receive and File; and Approve Discussions

That the Board of Commissioners receive and file the update and approve continued discussions with Washtenaw County Parks and Recreation Commission on the development and funding of the Border-to-Border Trail on Hudson Mills property north of North Territorial Road.

Background: The Metroparks applied for two MDNR Trust Fund Grants last March. The two projects were the Boat Launch Redevelopment Project at Stony Creek and the Land Acquisition project at Hudson Mills. The land acquisition project at Hudson Mills will improve the proposed alignment for the Washtenaw County Border-to-Border trail as it heads north from the park towards the Livingston County Border and the Lakelands State Park Trail. The Planning Department has submitted additional documentation to increase the scoring for both of these projects. Final scoring and the award of these grants will take place in December.

On a related issue, staff is requesting support for continued discussions with the Washtenaw County Parks and Recreation Commission on the development and funding of a two-mile section of trail at Hudson Mills located between North Territorial Road and McGregor Road. The Metroparks may be asked to cost share on a portion of this trail development. A meeting to discuss financial contributions and potential grant submissions in March will be scheduled in the near future. Other partners in the trail development heading north to the Lakelands State Park Trail include:

- Washtenaw County Parks and Recreation Commission
- Washtenaw County Road Commission
- Livingston County Road Commission
- Department of Natural Resources
- Hamburg Township
- Dexter Township

The Metroparks may be asked to contribute up to \$300,000 in the cost share on this project and apply for a MDNR Trust Fund Development Grant in March of 2015. This would require an update to The Metroparks existing Five-Year Recreation Plan, which does not include funding for this project.

The Border-to-Border Trail is part of the Governors Showcase Trail, which is an effort to connect trail systems from Wisconsin to Belle Isle in Detroit.

Continued updates will be provided as the project is planned.

That the Board of Commissioners receive and file the Natural Resources Department update regarding the Environmental Management Plan.

The Metroparks continues to make significant progress in the implementation and refinement of the Environmental Management Plan regarding mowing at the Metroparks. In addition, staff continues to engage the public and for input on the management of the natural resources within the Metroparks.

The Natural Resources Department is also focusing on implementation of large-scale removal of invasive species. Examples of these species include autumn olive, buckthorn, and bittersweet. It is important to note that because these are large-scale efforts, visitors and staff are going to see significant changes in the landscape at many Metroparks. For example, the NRC department is utilizing a contractor and staff to remove invasive species from Stony Creek and Hudson Mills. This will be a two-step process: (1) control shrubs; and (2) establish or maintain desired vegetation. To complete these objectives we will use multiple techniques such as mechanical control, herbicide, and/or the utilization of volunteers where appropriate.

By maintaining these grasslands using mowing, prescribed fire, or other methods as appropriate staff will complement the existing management plans for the Metroparks high quality natural areas.

The Natural Resources Department would like to acknowledge and thank staff for all of their efforts in assisting in the development and implementation of this plan.


