GEOCACHING regulations

Geocaching is an activity that the Huron-Clinton Metropolitan Authority permits. All people wishing to place a geocache within these parks must receive a permit and follow the regulations stated below to protect the sensitive areas of the park, maintain a safe and fun activity and to allow the park to monitor this use.

- 1. Participants must comply with all general Huron-Clinton Metropark Rules and Regulations.
- 2. Before a cache is placed in a park, a permit must be obtained from the park office. There is no charge for this permit. See the Geocaching Placement Site Permit Application for required information.
- 3. Geocaching site permits will be accepted between January 1 and April 15. On April 20 of each year, Metroparks Interpretive Services staff will inspect proposed sites for compliance with the Metroparks geocaching regulations. Permit approval or denial notifications will be sent via email to applicants by April 30. A record of approved permits will be maintained by each District's (Eastern, Western and southern) Interpretive Services Supervisor. Permits expire one year from the date of approval, and the permittee is responsible for removing his or her cache by the expiration date.
- 4. Cache locations must be naturally occurring hiding spots. There can be no trees cut, pruned or have things attached to them with nails, screws or other fasteners; holes dug; vegetation removed or planted; nor new items brought in such as sculptures, boxes, etc. No caches can be placed in birdhouses, nests, or in animal dens.
- 5. Due to safety concerns, no caches can be placed at a golf course.
- 6. Containers must be transparent and clearly marked "GEOCACHE." Do not use ammo boxes, PVC pipes or other containers that might cause alarm.
- 7. Offensive, illegal or dangerous items are not allowed in any cache.
- 8. Caches placed to promote commercial, political, religious or other social agendas are also not allowed.

On April 20 of each year, Metroparks Interpretive Services staff will inspect proposed sites for compliance with the Metroparks geocaching regulations. Permit approval or denial notifications will be sent via email to applicants by April 30. A record of approved permits will be maintained by each District's (Eastern, Western and southern) Interpretive Services Supervisor. Permits expire one year from the date of approval, and the permittee is responsible for removing his or her cache by the expiration date.

We ask that on the geocaching.com web page, the following statement be included:

"This cache is located within ______ Metropark. A Metroparks permit is required: \$10 daily pass, \$35 annual pass, \$21 annual seniors pass. All park rules and regulations apply. Park in parking lots only."

Park hours vary, so it is a good idea to include the park hours on your posting. Dogs are not allowed in the nature study areas. It is helpful to advise others if your cache location is pet friendly.

We request that you monitor this cache monthly and that you maintain it to be family friendly. This means the cache should not contain food, alcohol, firearms, drugs, dangerous items or adult items.
